Ministry of Public Administration and Local Self-Government, pursuant to Article 11. of the Law on Ministries ("Sluzbeni glasnik RS", No. 128/20), Article 29. paragraph 1 of the Law on Political Parties ("Sluzbeni glasnik RS", No. 36/09 and 61/15 – Constitution of RS), Article 23. paragraph 2 of the Law on State Administration ("Sluzbeni glasnik RS", No. 79/05, 101/07, 95/10, 99/14, 30/18 – other law and 47/18) and Article 136, paragraph 1 of the Law on General Administrative Procedure ("Sluzbeni glasnik RS", No. 18/16 and 95/18 – authentic interpretation), acting upon the application of the political party REFORMISTS OF VOJVODINA, represented by Nedeljko Sljivanac from Temerin, for entry of data change in the Register of Political Parties, which refers to the change of the address of the seat of the political party, issues a

RESOLUTION

In the Register of Political Parties, on the registration sheet number 19, on which the political party REFORMISTS OF VOJVODINA is registered, with its seat in Novi Sad, Vojvodjanskih brigada 17 / IV, represented by Nedeljko Sljivanac from Temerin, the change of data related to the change of address of the political party's seat is entered.

In the Column "Seat and address of the political party", new data is entered: Sremska Kamenica, Novi Sad, Jasmina 100.

Other data in the Register have not changed.

Rationale

The political party REFORMISTS OF VOJVODINA, submitted an application for entry of the change of data in the Register of Political Parties No. 00-00-00122 / 2021-28 dated 21 July 2021, which refers to the change of the address of the seat of the political party. The following documentation was submitted with the application: Minutes of the Extraordinary Assembly of the REFORMISTS OF VOJVODINA held on April 27, 2021. in Novi Sad, in the original, ie a certified transcript; Decision on change of the address of the seat of the REFORMIST OF VOJVODINA (Excerpt from the minutes from the Extraordinary Assembly of the REFORMIST of VOJVODINA held on April 27, 2021 in Novi Sad); Lease agreement; two copies of the Program and the Statute certified by the seal of the political party REFORMISTS OF VOJVODINA; proof of payment of the republic administrative fee.

Upon inspection of the Register of Political Parties, it was established that the political party with its seat in Novi Sad, Vojvodjanskih brigada 17 / IV, represented by Nedeljko Sljivanac from Temerin, was entered on the registration list number 19.

The provisions of Article 27 of the Law on Political Parties ("Sluzbeni glasnik RS" No. 36/09 and 61/16 – the Constitution of Serbia, hereinafter: the Law) and Articles 12 and 13 of the Rulebook on the Manner of Registration and Maintenance of the Register of Political Parties ("Sluzbeni glasnik RS" No. 51/09) stipulate that a political party is obliged to notify the Ministry of any change in data entered in the Register of Political Parties by submitting an application for data change in the Register, accompanied by the minutes from the session of the competent authority for making a decision on data change, in the original or a certified transcript, a decision on data change and proof of payment of the republic administrative fee. The said application is submitted by the representative of the political party. Article 29, paragraph 1 of the Law stipulates that the Ministry

shall issue a decision on the entry of a change of data in the Register within 30 days from the day of submission of a valid application.

After reviewing the application and submitting the documentation, the Ministry of Public Administration and Local Self-Government determined that at the Extraordinary Assembly of the party, held on April 27, 2021, a decision was made to change the data related to the change of seat address, in accordance with Articles 18, 20 and 22 of the Statute of the REFORMIST OF VOJVODINA of 24 November 2009, which is in the case file and which is certified by the seal of the Ministry and the signature of the official, as well as that the conditions prescribed by Article 27 and Article 29, paragraph 1 Of the Law on Political Parties and Art. 12 and 13 of the Rulebook on the manner of registration and keeping the Register of Political Parties, so it was decided as in the dispositive of the resolution.

Acting on the above-mentioned application, it was determined that the Program and the Statute of the REFORMISTS OF VOJVODINA dated April 27, 2021 were submitted to this Ministry. Having in mind that the inspection of the Minutes from the Extraordinary Assembly of REFORMISTS OF VOJVODINA held on April 27, 2021 in Novi Sad, it was determined that neither the Program nor the Statute were considered as agenda items at the said Assembly, they are not considered legally relevant evidence in the procedure regarding the application for registration of a change of data related to the address of the seat of the political party REFORMISTS OF VOJVODINA.

The fee for this resolution in the amount of 330.00 dinars was collected on the basis of tariff number 1 and in the amount of 13880.00 dinars on the basis of tariff number 21, paragraph 1, item 2 of the Law on Republic Administrative Fees ("Sluzbeni glasnik RS", No. 43/03, 51/03 – corrected, 53/04, 42/05, 61/05, 101/05 – other law, 42/06, 47/07, 54/08, 5/09, 54/09, 35/10, 50/11, 70/11, 55/12, 93/12, 47/13, 65/13 – other law, 57/14, 45/15, 83/15, 112/15, 50 / 16 – adjusted dinar amount, 61/17 adjusted dinar amount, 113/17, 3/18 – corrected, 50/18 – adjusted dinars amount, 95/18, 38/19, 86/19, 90/19 – corrected, 98/20 – adjusted dinar amount, 144/20 and 62/2021 – adjusted dinar amount).

INSTRUCTION ON LEGAL REMEDY: This decision is final in the administrative procedure and an administrative dispute may be initiated against it before the Administrative Court in Belgrade, within 30 days from the day of delivery of this decision. The court fee prescribed by tariff number 28, paragraph (1) of the Law on Court Fees, "Sluzbeni glasnik RS", No. 28/94, 53/95, 16/97, 34/01 – other law, 9 / 02, 29/04, 61/05, 116/08 – other law, 31/09, 101/11, 93/12, 93/14, 106/15 and 95/18) in the amount of 390.00 dinars.
